# Essential information

## What do the rates apply to?

This applies to any form of (background and/or entertainment) music played through radio, television, streaming services, CD players, and/or other playback devices. Please note: Use of consumer streaming services (e.g., Spotify) is not permitted in a business environment.

## What are the tariffs based on?

Defining factors include the purpose of the music, the number of visitors, the audience reach, and the area of the room where the music is played.

## How are the tariffs calculated?

Depending on the type of music use, Sena uses scales based on the surface area (m<sup>2</sup>) of the publicly accessible spaces (e.g. in supermarkets, department stores, company restaurants and hospitality venues) or based on the number of full-time employees (FTEs) (e.g. in workshops, offices and warehouses). Special forms of music use, for example in an aircraft or on a website, have a different fee structure.

## How are the tariffs calculated by Sena?

Sena applies individual rates for each type of music usage, which have been determined through discussions and collaboration with representative trade organisations.

## What does the licence cover?

The licence only covers the use of music played in the room(s) and/or location(s) for which the licence has been issued. Music licences are set and calculated based on the location and type of publication.

## Collaboration with trade organisations

Sena has reached collective licensing agreements with several trade organisations. The licences for organisation members are processed collectively in one go. This administrative saving offers an attractive discount. If your trade organisation has agreed a collective arrangement for its members with Sena, the secretariat of your trade organisation can provide you with more information.

## Basic tariff and discounted tariff

The following pages list the tariffs that apply to your situation. The tables show the basic tariff and the discounted tariff. The discounted tariff applies if you register the music usage independently and pay the invoice on time. For this, we apply a discount of up to 33.33% on the basic tariff. If our Field Managers discover music use that has not been voluntarily reported or if the invoice has not been paid on time, you will be required to pay the basic tariff plus the statutory interest and possible legal collection costs. Companies already registered with a licence will automatically receive the discount, provided the invoice is paid on time.

## Annual indexing

The agreement with the Copyright Expert Committee from VNO-NCW and MKB-Nederland ("CAR") involves the annual adjustment of tariffs using a standardised indexation method. Since 2012, BumaStemra, Sena and Videma have used the same methodology, which calculates the average of the CPI index for the most recent 12 months (from June to June) table CPI derived, as published by the Central Bureau of Statistics (CBS).

## VAT

The tariffs provided in this overview are annual and exempt from VAT.

# RAAP-PPI surcharge on Sena tariff 2026

The RAAP-PPI ruling<sup>1</sup> of the European Court of Justice led to a change in the law in the Netherlands as of 1 January 2021. As a result of this legal change, Sena is now required to invoice a surcharge to music users.

The change in the law means that repertoire for which Sena collects has been expanded. Based on the Neighbouring Rights Act, previously only repertoire whose original master owner is based in a country that has signed the Treaty of Rome was protected for all forms of publication under the Sena mandate. Since 1 January 2021, repertoire from all countries that have signed the WIPO Performances and Phonograms Treaty (WPPT), including the United States, is now protected and must be represented by Sena. This means more repertoire is protected, and Sena is therefore obliged to impose a surcharge.

The Copyright Expert Committee of VNO-NCW, MKB-Nederland and Sena have discussed the implications of this legal change for rightsholders and music users, as well as strategies to prevent lengthy legal proceedings. Taking into account the interests of both music users and Sena rightsholders, the parties have successfully negotiated a commercial agreement. The following surcharges apply from 1 January 2021:
